Please read carefully:

It affects any rights you may have if you, your dogs or cats, or anybody you bring along with you are injured or otherwise suffer damages while participating in the boarding program at North Valley Veterinary Center. It also states your responsibility regarding fees and expectations associated with our boarding program and boarding at North Valley Veterinary Center.

I _____, (participant/owner of animal(s)) hereby agree to the following covenants described below regarding the boarding program and North Valley Veterinary Center.

I further release, wave, discharge, and covenant not to sue North Valley Veterinary Center and any of the officers, servants, agents, employees, and volunteers of the above-mentioned entities (hereinafter referred to as RELEASERS) for any liability, claim and/or cause of action arising out of or relating to any loss, damage, or injury, including death, that occurs because of my participation in the below-describes.

1. Participation in North Valley Veterinary Center's boarding program is voluntary. We reserve the right to excuse any animal(s) from boarding at any time for negative behavior.
2. It is the participant's choice to bring other people to the boarding area at his or her own risk and it is the participants responsibility to ensure their safety and well-being.
3. Releasers do not guarantee an animal(s) behavior at any time. We can only evaluate and supervise to the best of our ability.
4. I further understand that North Valley Veterinary Center has relied upon my representation that my animal is in good health, is not in heat (females), and has not injured or shown aggression or threatening behavior to any person or animal in admitting my animal for services at their facility.

5. Participating animals are to be current on their vaccinations. Dogs are required to be current on DA2PP, BORDETELLA, and RABIES vaccines. Cats are required to be current on FVRCP, FELV, and RABIES vaccines.
6. Releasers are not responsible for any incident or accident arising from the travel to the daycare and or boarding sessions or after leaving daycare or boarding.
7. North Valley Veterinary Center, hereby has permission to use any photos taken of you and your pet during boarding for advertising purposes. Names of participants will not be printed or released.
8. Daycare pets will be supervised at all times during regular business hours, however, I understand there is no supervision after business hours. By signing below, I am giving permission for my pet(s) to board unsupervised during after hours and I understand that there are risks involved.
9. I further understand that the releasers will not be liable, financially, or otherwise, for injuries to my pet, me or any property of mine while my pet is participating in services provided by North Valley Veterinary Center. I hereby release North Valley Veterinary Center of any liability of any kind arising from my pets participation in any and all services provided by North Valley Veterinary Center.
10. I further understand and I am solely responsible, financially or otherwise, for any harm or damage caused by my pet(s) while attending any services with North Valley Veterinary Center.
11. I further understand and agree that if any problems should arise with my pet(s), behavioral/medical or otherwise, they will be treated as deemed best by the attending veterinarian of North Valley Veterinary Center in view of what is in the best interest of my pet. I understand that I assume full financial responsibility and all liability for any and all expenses in regards to the behavior and help of my pet(s).
12. If your pet(s) becomes ill or injured and it is deemed an emergency by the attending staff, and we are unable to reach you, please indicate your wishes below:

Please perform whatever services the doctor deems necessary for the best care of my pet until someone can be reached. I authorize up to \$_____ to be spent on medical services.

Do not administer any non-emergency medical services until specific authorization is given.

I understand that if my pet(s) is not picked up on time or by a specified date in the separate agreement I hereby authorize North Valley Veterinary Center to take whatever action is deemed necessary for the continuing care of my pet(s). I will pay North Valley Veterinary Center the cost of such ongoing care upon demand by North Valley Veterinary Center. I understand that if I do not pick up my animal, North Valley Veterinary Center will proceed according to guidelines provided by Los Angeles County of Animal Services. I also acknowledge that I will be fully responsible for all attorney fees and associated costs if I abandon my pet(s). I am also aware that willful animal abandonment is a misdemeanor. (Penal code 597s)

Pets may be picked up 9am-11:30am or 2pm-4:30pm Monday-Sunday. Exceptions may be made at additional cost and/or with prior approval.

By signing this disclaimer, agreement and waiver, I state that I have read and understand the conditions set forth in this disclaimer, agreement and waiver and I agree to all conditions set forth herein and I sign this voluntarily.
